01 The timing map

Windows rank across the horizon. Each shows its dates, its state, the force in plain language, and the evidence behind it.

02 Identity

Northpoint Analytics Inc. sits squarely in Mercury territory. Mercury rules commerce, contracts, analysis, and records, and the company's current mahadasha has been Mercury-led since late 2016, running through 2033. That long arc points to a firm built around data work, analytical services, or information-driven advisory, somewhere language, numbers, and structured reasoning do the core work. The company Moon in Leo adds a layer of public-

facing confidence, suggesting the brand carries some authority in how it presents findings to clients. As of mid-2026, the period has moved into a Mercury-Rahu antardasha, which brings Rahu's appetite for unconventional reach and leverage into the mix, a signal that the firm may be stretching into new territory or experimenting with tools and methods outside its original scope. *Synthesis*

03 **The honest hard parts**

The Mercury/Rahu period running through late 2028 carries real friction: Rahu amplifies appetite and Mercury rules the contracts and data that Northpoint Analytics depends on, so the combination can push the company toward commitments that outpace its actual capacity to deliver. Saturn's nature as the planet of structure and slow compounding means any shortcuts taken during this window tend to surface later as operational debt, not immediately but steadily. The Leo Moon in the company chart points to cash rhythm and customer sentiment as pressure points, and Leo's fixed quality means the flow can look stable right up until it isn't, making this a period to watch receivables and client concentration carefully. None of this forecloses good work, but the caution window is genuine, and the periods ahead reward discipline more than speed. *Synthesis*

04 **Working practices**

Northpoint Analytics operates inside a long Mercury mahadasha, so the core rhythm favors precise communication, tight contracts, and analytical output over raw growth pushes. The current Mercury/Rahu antardasha running through late 2028 carries a caution flag: Rahu amplifies appetite and can pull Mercury-ruled work toward overreach, so this window is better used for refining existing offerings and strengthening written agreements than for launching untested lines. The Gemini Moon in the owner chart responds well to frequent, lightweight check-ins rather than long planning cycles, while the Leo company Moon needs visible momentum to keep client confidence steady, so small public signals of progress serve both rhythms. When a cleaner sub-period arrives within the Mercury mahadasha, the conditions may suit a more deliberate push outward, but for now the practical edge is in depth of execution, not width of reach. *Synthesis*
